### **THE SHOREHAM PORT AUTHORITY HARBOUR REVISION ORDER 2021 SHOREHAM PORT – GENERAL DIRECTIONS 2021**

NOTICE IS HEREBY GIVEN that in exercise of its powers under the Shoreham Port Authority Harbour Revision Order 2021, the Shoreham Port - General Directions 2021 have been given by the Shoreham Port Authority. The General Directions will come into force on 28th June 2021 and replace the Shoreham Port General Directions 2010 (updated 2013) and apply to the entire Port including the Port Premises (as stated in the General Directions and shown on the plans annexed to or published with the General Directions).

It is therefore important that all Port users are aware of these General Directions and abide by them.

The General Directions have been given for the purpose of promoting or securing conditions conducive to the ease, convenience or safety of navigation in the Port, the safety of persons, the protection of property, flora or fauna, or the ease, convenience or safety of port operations ashore.

In respect of vessels, it is important that Master's and Officers are aware of these General Direction and Local Notices to Mariners, as well as any Special Directions applying to their vessel. It is therefore vital that owners and agents ensure all such relevant information and publications are promptly distributed to vessels as appropriate.

Note should also be taken of the content of broadcasts from Shoreham Harbour Radio.

It is the duty of the Master of a vessel to which a General Direction or a Special Direction applies to comply with that Direction. However, the giving of a General Direction or Special Direction shall not diminish, or in any other way affect the responsibility of the Master of the vessel to which the Direction is given in relation to their vessel, persons on board, its cargo or any other person or property.

A copy of the General Directions have been deposited at Shoreham Port, Nautilus House, 90-100 Albion Street, Southwick, Brighton BN42 4ED and may be inspected between 09:00 – 15:30 hours if local COVID-19 restrictions allow.
